#### **RESOLUTION #18-03**

## A RESOLUTION ADOPTING THE PREVAILING WAGE RATES FOR LABORERS, MECHANICS, AND OTHER WORKERS ON PUBLIC WORKS OF THE OAKBROOK TERRACE FIRE PROTECTION DISTRICT, DUPAGE COUNTY, ILLINOIS

WHEREAS, the State of Illinois has enacted "an Act regulating wages of laborers, mechanics and other workers employed in any public works by the State, County, City or any public body or any political subdivision or by anyone under contract for public works," approved June 26, 1941, as amended, and codified as 820 ILCS 130/1 et seq; and

WHEREAS, the aforesaid Act requires that the Oakbrook Terrace Fire Protection District investigate and ascertain the prevailing rate of wages as defined in said Act for laborers, mechanics and other workers in the locality of York Township employed in performing construction of public works for said Oakbrook Terrace Fire Protection District

WHEREAS, if the District does not investigate and ascertain the prevailing wage rates during the month of June, then the prevailing wage rates for the District shall be the rate as determined by the Illinois Department of Labor under Section 9 of the Act (820 ILCS 130/9); and

WHERAS, the aforesaid Act further requires that the District make and keep, for a period of not less than three (3) years, certified payroll records of all laborers, mechanics, and other workers employed on particular projects.

# NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF TRUSTEES OF THE OAKBROOK TERRACE FIRE PROTECTION DISTRICT, AS FOLLOWS:

SECTION ONE: To the extent, and as required by "an Act regulating wages of laborers, mechanics and other workers employed in any public works by State, County, City or any public body or any political subdivision or by anyone under contract for public works," approved June 26, 1941, as amended, the general prevailing rate of wage in this locality for laborers, mechanics and other workers engaged in construction of public works coming under the jurisdiction of the Oakbrook Terrace Fire Protection District is hereby ascertained to be the same as the prevailing rate of wages for construction work in DuPage County, as determined by the Department of Labor of the State of Illinois as of June 2017, a copy of that determination being attached hereto and incorporated herein by reference as **Exhibit A**. As required by said Act, any and all revisions of the prevailing rate of wages by the Department of Labor of the State of Illinois shall supersede the Department's June determination and apply to any and all public works construction undertaken by the Oakbrook Terrace Fire Protection District.

The definition of any terms appearing in this Resolution which are also used in aforesaid Act shall be the same as in said Act.

**SECTION TWO:** Nothing herein contained shall be construed to apply said general prevailing rate of wages as herein ascertained to any work or employment except public works of the Oakbrook Terrace Fire Protection District to the extent required by the aforesaid Act.

**SECTION THREE:** The Secretary of the Board of Trustees of the Oakbrook Terrace Fire Protection District shall publicly post or keep available for inspection by any interested party in the main office of the Oakbrook Terrace Fire Protection District, this determination or any revisions of such prevailing rate of wage. A copy of this determination or of the current revised determination of prevailing rate of wages then in effect shall be attached to all contract specifications.

**SECTION FOUR:** The Secretary of the Board of Trustees of the Oakbrook Terrace Fire Protection District shall mail a copy of this determination to any employer, and to any association of employers and to any person or association of employers who have filed their names and addresses, requesting copies of any determination stating the particular rates and the particular class of workers whose wages will be affected by such rates.

**SECTION FIVE:** The Secretary of the Board of Trustees of the Oakbrook Terrace Fire Protection District shall promptly file a certified copy of this Resolution with the Illinois Department of Labor.

**SECTION SIX:** Within thirty (30) days after the filing of a certified copy of this Resolution with the Illinois Department of Labor, the Secretary of the Board of Trustees of the Oakbrook Terrace Fire Protection District shall cause to be published in the newspaper of general circulation within the area a copy of the Notice of Determination substantially in the form of **Exhibit B** attached hereto and made part hereof, and such publication shall constitute notice that the determination is effective and that this is the determination of this public body.

**SECTION SEVEN:** This Resolution shall be in full force and effect from and after its passage, approval, and publication according to law.
